Iowa Administrative Code 701.71.1 (3) states: Land and the non-residential improvements and structures located on it shall be considered to be primarily for agricultural purposes if its principal use is devoted to the raising and harvesting of crops or forest or fruit trees, the rearing, feeding, and management of livestock, or horticulture, all for intended profit.

The above administrative rule is intended to determine if a property qualifies for agricultural classification based on the following three key aspects of the rule:

1. Principal or *Primary Use*
2. *Used in good faith for agricultural purposes*
3. *For intended profit*

The farming operation must be in “good faith used primarily for agricultural purposes.” A few cows and a horse on pastureland, for example, would not be sufficient where the parcel is also the site of a residential dwelling. The primary use of the property would be residential, and secondary use would be agricultural.

The Assessor may ask for additional information, including this questionnaire and/or mortgage related information, to determine the proper classification of a property. Any information provided to the Assessor to determine classification is considered public and will not be kept confidential.
