**TERMS AND CONDITIONS:**

1. All bids shall be submitted on the provided form (page 3), in a sealed envelope, to the Benton County Auditor's Office (111 E 4<sup>th</sup> Street, Vinton, IA 52349) with the words "Animal Shelter bid" written on the outside of the envelope. Sealed bids must be submitted in a sealed envelope either by mail or hand delivered to Benton County Auditor's Office no later than 12:00 pm on Friday, February 6th, 2026.
2. Each bidder must specify one of the following:
  - a. Enter into a binding agreement with the Benton County Board of Health that the time of transfer inspection will not be required and the buyer agrees that a code compliant private sewage disposal system or connection to a public sewer shall be installed to serve the property and shall be completed no later than June 1, 2026.

**OR**

  - b. Enter into a binding agreement with the Benton County Board of Health that the time of transfer inspection and upgrading of the private sewage disposal system serving the property will not be required as long as the structure is not occupied and is demolished by June 1, 2026.
    - i. Once the structure is demolished, the private sewage disposal system shall be properly abandoned which includes pumping the septic tank, crushing in the tank lid, and filling the tank with sand or soil.
    - ii. Documentation of the abandonment shall be provided to Benton County Environmental Health.
3. This property has a minimum acceptable bid amount of \$10,000. Any bid less than \$10,000 will NOT be accepted NOR will the bidder be allowed to increase their bid at the meeting when all bids are unsealed.

4. Any bid that includes statements such as “I bid \$1 more than the highest bid,” will NOT be accepted NOR will the bidder be allowed to increase their bid at the meeting when all bids are unsealed. ONLY specific dollar numbered bids will be accepted.
5. Any sealed bid form not filled out in its entirety will not be accepted. PLEASE read the sealed bid form carefully.
6. Any bid received after 12:00 pm on February 6, 2026, will not be accepted.
7. Other than the septic clause (included in sealed bid form), the property is being sold “as is.”
8. The deed for this property will be conveyed through a quitclaim deed.
9. All sealed bids will be unsealed at 10:30 am on February 10<sup>th</sup>, 2026, in the Conference Room, Benton County Service Center, 811 D Ave. Vinton, Iowa. Thereafter, any bidder physically present will be allowed to increase their bid so long as the original bid meets the minimum acceptable bid amount and the sealed bid form is filled out in its entirety. **No proxy nor a third-party** are allowed to increase the bid of a sealed bidder who is NOT physically present at the revealing of the sealed bids.
10. The winning bid must be paid, in full, by bidder within two weeks of the Board of Supervisors accepting such bid. If non-payment occurs, the bidder is to be considered as to having revoked their bid on the property for sale.
11. The Benton County Board of Supervisors reserves the right to reject any and all bids.
