ORDINANCE #39

TITLE: Ordinance Establishing the Penalty for County Infractions.

Be it Enacted by the Board of Supervisors of Benton County, Iowa:

SECTION 1. PURPOSE. This Ordinance is created to protect the health, safety, and welfare of Benton County and its residents by establishing the penalty for violations of county ordinances.

SECTION 2. ENACTMENT. This Ordinance adopts by reference and incorporates herein Iowa Code Section 331.307 and all subsequent amendments and revisions thereto and hereby establishes the penalty contained in Section 331.307 as the penalty for violations of certain Benton County ordinances.

SECTION 3. APPLICABILITY. This Ordinance hereby establishes and applies Iowa Code Section 331.307 to the following Benton County ordinances:

Ordinance #17, Ordinance Prohibiting the Creation or Maintenance of a Nuisance Within Benton County.

Ordinance #21, Litter Control Ordinance of Benton County.

Ordinance #24, Benton County, Iowa, Agricultural Land Preservation Ordinance.

Ordinance #26, Subdivision Ordinance.

Ordinance #34, Water Wells. Section 3 of Ordinance #34 is further amended to state that failure to comply with any Board of Health Order shall constitute a county infraction as authorized by Iowa Code Section 331.307.

Ordinance #37, Vicious Animal Ordinance.

Ordinance #38, On-Site Waste Water Treatment and Disposal Systems.

A violation of any requirement of the above referenced ordinances is a county infraction as specified in Iowa Code Section 331.307 and all subsequent amendments and revisions thereto.
