## ORDINANCE #78

TITLE: An Ordinance Readopting the Existing Benton County Code of Ordinances and/or Repealing Certain Portions Therein.

Be it Enacted by the Board of Supervisors of Benton County, Iowa:

**SECTION 1.** Purpose. Iowa Code Section 331.302, Subsection 9, requires that once every five years a County shall compile its Code of Ordinances. This Ordinance readopts ordinances already in effect in Benton County, Iowa, and/or repeals any ordinance deemed no longer necessary to the operation of Benton County, Iowa. This ordinance also reorganizes the Benton County Code of Ordinances into chapters by subject matter.

**SECTION 2.** Readoption of Current Code. The following ordinances have been previously adopted and enacted into law and were duly published as the law provides. The ordinances are stated herein by subject matter and number, and by the authority of the Benton County Board of Supervisors comprise the Benton County Code of Ordinances.
