ORDINANCE #54

TITLE: An Ordinance Readopting the Existing Benton County Code of Ordinances and/or Repealing Certain Portions Therein.

Be it Enacted by the Board of Supervisors of Benton County, Iowa:

SECTION 1. Purpose. Iowa Code Section 331.302, Subsection 9, requires that once every five years a County shall compile its Code of Ordinances. This Ordinance readopts ordinances already in effect in Benton County, Iowa, and/or repeals any ordinance deemed no longer necessary to the operation of Benton County, Iowa.

SECTION 2. Readoption of Current Code. The following ordinances have been previously adopted and enacted into law and were duly published as the law provides. Copies of the Code as adopted herein shall be on file and available for public inspection in the County Auditor's office and County Attorney's office.


SECTION 5. When Effective. This Ordinance shall be effective after its final passage, approval, and publication as provided by law.
