<u>Introduction and/or presentation by Amy Grunewaldt, MSW - Linn County Early Childhood</u> <u>Iowa/DECAT; Benton/Iowa County – DECAT:</u>

Amy provided an update on Benton/Iowa County DECAT & ECI. For FY26, the CPPC budget is approximately \$8,000.00; for the proposed Benton County Social Services Directory project in partnership with BCPH, any proposals of \$1,500.00 or above have to go up for bid – Grace & Amy will continue to work on this, as the proposed project cost for BCPH staff time & materials

was \$2853.79. For ECI, there has been an overall funding shrinkage of approximately 30%, and alignment with the 7 behavioral health districts is being looked at.

Environmental Health – Updates

 FY26 Private Well Grants contract has been signed, BCEH waiting to receive fully executed contract from the state, expected to be returned this month

Discuss and approve the job description for a Sanitarian/Land Use Administrator:

Chair Burkhart had this put on the agenda, looking at succession planning moving forward; the
job description for Sanitarian/Land Use Administrator needs to be reviewed & updated. It was
discussed that looking at examples and coming back to meet in a few weeks would be most
optimal.

- Chair Burkhart will work with the Benton County Auditor on the job posting, will continue to discuss at the next BOH meeting; a special session was discussed for 2 weeks from now, on 8/22/2025 @ 7:00am.

- Schmidt presented the public health report from the previous month, including updates on the PHEP grant, Local Public Health Services grant, Immunization grant, 6-Year Response grant, continuing education opportunities, stakeholder meetings, outreach activities and disease investigation. On the topic of continuing education, it was noted by Chair Burkhart that due to open records rules being changed, training on this subject will be required for Board members appointed after 7/1/2025.
