Supervisor Seeman explained how they were looking for two small rooms and a conference room. The only thing accommodating would be the old Human Resources office space. No action was taken. ASAC will visit the board at a later date with their long-range plans.

WHEREAS the Parties will file with the Court a consent decree memorializing the full terms and conditions of the Parties' compromise settlement agreement following approval of the compromise settlement by a majority of the member counties.
