

## **Request for Sealed Bid – October 13, 2020**

### **Benton County Conservation Yurts**

#### **To all interested bidders:**

Benton County Conservation is accepting sealed bid proposals at the Benton County Conservation Nature Center (5718 20<sup>th</sup> Ave Dr, Vinton, IA 52349) until 2:00pm on Monday, November 9, 2020 for the purchase of each yurt located at Rodgers Park.

#### **Terms:**

- Each bid must specify which yurt the bidder is interested in individually: North Yurt or South Yurt.
- Bidders may bid on both yurts, with separate bids.
- Yurt is purchased as is, with all items within the yurt as one package, not including the water softener.
- Benton County Conservation must have the payment prior to the removal of the yurt.
- Purchaser must take down and haul away the yurt by December 7<sup>th</sup>, without any assistance from the department.
- All items must be respectfully removed and location made clean once yurt is out, without harm to existing utilities.
- Once the bid is accepted on November 9<sup>th</sup>, bidder will be contacted by November 10<sup>th</sup>. A check must be made out to Benton County Conservation and in the department's possession by November 16<sup>th</sup>, 2020 at 10:00am.

#### **Yurt Information:**

- Two 24' Colorado Yurt Company Yurts were installed at Rodgers Park in October of 2015.
- Yurts come with a center wall, heating and cooling unit, bed and frame, end table, kitchen table, two kitchen chairs, apartment sized fridge, apartment sized freezer, toilet, shower, ceiling fan, and more.
